1.	Approval of minutes of 112 th meeting of the Senate	Approved
2	Results – UG and PG; Results of PhD 2019-20 Dean Academic has presented the II, III & IV year and Exam mode results of B.Tech., I & II year M.Tech., I, II & III year M.Sc., I (Q1 & Q2) & II (Q5&Q6) year MBA received from all the departments. All the results are passed by the senate except the following subjects needing clarification / revision. The Chairman, Senate suggested to make the necessary changes/corrections and send the revised grades of these subjects for Chairman Senate approval.	
	UG results	<ul style="list-style-type: none"> The grades of the many of the subjects in II, III and IV year of Biotechnology are referred back to revise and resubmit to the Chairman Senate In Chemical Engineering Average, SD and Ranges are not submitted for some of the subjects III & IV year and HOD is requested to revise and re-submit them. In IV year CSE, the members suggested to correct the ranges for E and P grades for Machine Learning lab. In the exam mode results of the Mechanical Engineering dept., the E grade awarded in the subject – SM335 – Engineering Economics and Accountancy for 2013 joining batch student (Aditi Gupta, Roll no. 133104) are referred back to revise as there is no E grade for the students joined before 2017. MOOCS course results should be submitted along with 8th semester results.



	PG Results	<ul style="list-style-type: none"> In ECE, I year VLSI, the ranges and number of students appeared need to be corrected in few subjects. The grades of the subjects Computational Techniques, Optimization Techniques, Computational Techniques Lab, Process control lab and Seminar of I year M.Tech. Chemical Engineering and Process control are referred back to revise as the average is not in C grade. In M.Tech (Biotechnology), all the subject ranges have to be revised and re-submit the grades. In MBA, members suggested to give absolute grading for the two students in two subjects. <p>Chairman Senate suggested to submit justification for the subjects in case of low (<50) and high (>70) averages.</p>
	Ph.D	Dean Academic presented the course work and comprehensive viva results submitted by all the departments and the results are passed.
3.	PhD – Registrations elapsed for 2 semesters or more	<p>Dean Academic presented the list of Ph.D scholars received from various departments, who have not registered for more than 2 semesters consecutively, along with the DAC PG&R recommendation. Senate approved the cancellation of the registrations of these students henceforth.</p> <p>For full-time to part-time conversion, the modalities need to be revised and this has been referred to Academic standing committee for its recommendations by the Chairman, Senate.</p> <p>In case of Chandra Mohan, research scholar from Chemistry department, the cancellation of registration is deferred as the issue is still in court.</p>
4.	Physics – Request for late Registration and Change of Supervisor	<p>Dean Academic presented the DSC and DAC recommendations with respect to the request for late registration of external research scholar Mr. Kishore K Aitha (Roll no. 715086) to the senate and Senate approved the same.</p> <p>Dean Academic requested HOD, Physics to present the request by the part-time research scholar, N. Chaitanya (Roll no. 717163) for change of external supervisor from Dr. I.M. Chhabra to Dr. Sree Ramana. Senate approved the change.</p>
5.	Metallurgy – Request for early submission of PhD Thesis	Dean Academic presented the request made by the MME department for early submission of PhD thesis by Mr. R. Senthil Kumar (Roll No.717138), part-time research scholar, who has met all the




		requirements. Senate Approved the recommendation of MMED.
6.	EEE – Evaluation of M.Tech. electives offered to B.Tech. students	Dean Academic presented the recommendation proposed by EEE department regarding the evaluation M.Tech. electives offered to B.Tech. students. The department recommended the same evaluation as that of M.Tech. for all the registered students including B.Tech. students for these electives. Senate approved the recommendation and suggested all the departments to follow the same.
7	Science Depts. – to start 5 Year Integrated courses	Dean Academic requested the HOD Physics to present the proposal of 5 year integrated courses on behalf of all the three science departments. Senate approved the proposal to offer the integrated course in principle. However Chairman, Senate referred this to Academic Standing Committee to look into the intricate details, modalities and implementation issues by considering all the suggestions given by Prof. CSRK, Prof. Neelakanteswara Rao, Prof. DVSSS, Prof. KVJ, etc. Chairman Senate also requested the members to send the suggestions to Dean Academic in this regard.
8	Suggestions for the Curriculum revision in line with the NEP	Senate Chairman insisted all the departments to follow NEP guidelines for the forthcoming curriculum revision.

10.	Clarification regarding GRADE mapping from old (2011) to new (2017) regulations.	Senate approved to map P grade to E grade for such students and members suggested to minute it and authorize Examination section to map the grade.
11.	Suggestions for Curriculum Revision in line with NEP	Chairman Senate gave a brief introduction about the need for curriculum revision in line with NEP and requested Prof. CSRK Prasad to give a short presentation on the same to ignite the thought process. Prof. Prasad has presented key points on various aspects in curriculum revision. Chairman Senate thanked Prof. Prasad for giving a good


