Leave of absence was approved for all the members who could not attend the meeting.

The Chairman, Senate welcomed all the Senators, Special Invitees and Student Representatives to the meeting.

2024-130-Senate-01

- (a) Request of Mr. Mohammed Omar Anjar (22CEB0A01) to change the R-Grade to F-Grade in Fluid Mechanics-2; Concrete Technology; and Numerical Statistical methods.
- (b) Request of Mr. Mohammed Murtaza (22CSB0A01) to change the R-Grade to F-Grade in all the courses of III semester.

The above requests have been referred to SUGC. SUGC noted that there is no provision to convert "R" grades to "F" grades and recommended that both the students have to attend the courses in study mode, as and when the said courses are offered. SUGC recommends to proceed with the decision taken in the 129th Senate meeting held on 16-01-2024 with regard to Mr. Masroor Ahmed.

The Senate approved the recommendation of the SUGC. The Senate suggested to initiate suitable disciplinary action against the above students through Institute Standing Disciplinary Committee.

- (c) Mr. Nareshkumar Reddy Pallela (22MER1P03), a part-time Research Scholar (ME) has made a request that his absence in the previous semester may be treated as temporary withdrawal on medical grounds. The DSC has recommended the request. The Senate approved the request as a special case. Chairman, Senate suggested that all such requests shall be rooted through RPEC in future.
- (d) The following requests of Research Scholars have been referred to RPEC.
 - (1) Mr. K. Harish Kumar (21CEPJ002) and Mr. K. Mallikarjuna Reddy (21CEPJ023), Part-time Research Scholars (CE) have requested to allow them to attend Comprehensive Viva-Voce Examination. Both of them are in their 6th semester in their PhD program.
 - (2) Ms. Swati Sarma (22CER1P12) a Full time Research Scholar (CE) has requested to allow her to attend Comprehensive Viva-Voce Examination. She is in 4th Semester.
 - Both the requests have been referred to RPEC. RPEC observed that as per the rule Comprehensive Viva-Voce has to be completed by third semester and recommends to cancel the admission with respect to Mr. K. Harish Kumar and Mr. K. Mallikarjuna Reddy. However, RPEC recommends to permit Ms. Swati Sarma as a special case.

The Senate approved the recommendations of RPEC. The Senate suggested that the Supervisor and the DSC will have to take responsibility for conducting the comprehensive viva voce examination as per rules.

- (3) Mr. A. Chandra Mohan (717168), a Full-time Research Scholar (CY) has made a complaint that the facilities such as chemicals and equipment required for carrying out his Research are not being made available by the Department. The issue has been referred to RPEC.
 - RPEC discussed with the Head of the Department (CY), Supervisor and the Research Scholar. RPEC recommends the following:

Committee asked the student to restrain from making this type of complaint. The student has been advised to look for facilities available in the entire institute for his research. At the same time the Supervisor and HoD have been requested to facilitate the student with the available resources in a productive way.

The Senate noted the recommendations of RPEC. The Chairman, Senate suggested to refer the case to Institute Standing Disciplinary Committee. The Chairman further expressed dissatisfaction for the equipment being kept in the faculty rooms instead in the laboratories. It is recommended all the equipment facility shall be made available to the students and faculty members of the Department.

- (4) Mr. S. Siva Kumar a full-time Research Scholar has made a request for allowing him re-admission into PhD program. The issue is referred to RPEC.

 After going through the record of Mr. S. Siva Kumar, RPEC observed the following:
 - Admission of Mr. S. Siva Kumar has been cancelled in the year 2022 (120th Senate) because of non-registration for more than 3 successive semesters.
 - The claim of Mr. S. Siva Kumar that he has registered is found to be incorrect, as his registration was neither forwarded nor signed by the Supervisor as well as the Chairman, DSC. Further it was observed that the student has not presented his progress before the DSC for 3 semesters.
 - He has already completed the maximum period of eight years by the year
 2022.

In view of the above, RPEC recommends that Mr. S. Siva Kumar's request for re-admission into the program should not be entertained.

The Senate approved the recommendation of RPEC.
