should have the date on which the action is taken. The ATR should indicate the target dates of the activities, actual date of completion, revised date in case of any revision, reasons for delay in completing the activities, the Agent responsible for delays, action initiated for controlling the delays, whether contract clauses have been invoked in case of delay by Contractor etc. The planned progress and actual progress on date should be presented in the form of a Bar Chart by CPWD in every BWC Meeting for all works undertaken by them.

Review of the ongoing construction works in the campus through Central Public Works Department (CPWD).

B.W.C. Item No.24.3

Resolution

- 1. Construction of 2nd floor over Mechanical Engineering Department (PG Block) building facing west at NIT, Warangal (Civil and Electrical works) M/s Amaleswari Constructions Agmt. No.08/EE/NSGPD/2011-12: In the 23nd meeting of BWC, the Committee was informed by CPWD that the work will be completed and handed over by 30.04.2014. However, the work is not yet completed. CPWD informed the Committee that the work will be completed by 30.06.2014. CPWD has stated that delay was due to insufficient mobilization of the work force by the contractor. Milestone of the contractor has already been withheld. CPWD has further stated that compensation will be levied on the contractor for the delay in completing the work as per the terms of the agreement. The Committee suggested that work should be completed by 30.06.2014 without any further delays.
- 2. Construction of 2nd floor over NAB and balance portion of first floor over Computer Centre Building at NIT, Warangal (Civil and Electrical works) - M/s TSR Constructions Agmt. No.01/EE/NSGPD/2012-13: In the 23rd meeting of BWC, the Committee was informed by CPWD that the work will be completed and handed over by 30.04.2014. However, the work is not yet completed. CPWD informed the Committee that the work will be completed by 30.06.2014, except installation of lift. The installation work of lift will be taken up as soon as the necessary civil works are completed. The installation of lift will be completed by 31.07.2014. CPWD stated that due to slow progress of work, the original agreement was rescinded. Consequent upon the rescinding of the work, tender for balance work was called and balance work started from 29/4/2014. Performance guarantee and security deposit of the original agreement have been forfeited. The Committee suggested that work should be completed by the target dates without any further delay.
- The Joint Inspection Committee constituted for quality inspection and handing over of the works completed by CPWD, inspected the following works in the first week of February, 2014.

- Renovation of old boys' hostels blocks VI, VII and VIII
- Construction of second floor on Department of ECE
- Completion of balance works in Centre of Advanced Materials (CAM) and Centre for Automation and Instrumentation (CAI).
- · Re-carpeting of all internal roads
- Renovation of Staff Quarters
- 4. The Joint Inspection Committee was satisfied with the work carried out in old boys' hostel blocks VII and VIII and they were taken over by the Hostel Office. However, the committee was not satisfied with the quality of work in certain portions of the hostel block VI (the plastering and putty work in some of the rooms were not satisfactory). CPWD was asked to redo the work in these portions. The committee inspected the work again on 20.03.2014. The work was found to be satisfactory and the hostel block was taken over by the Institute.
- 5. The Joint Inspection Committee was satisfied with the work in CAM and CAI buildings. Subsequently the buildings were taken over by the Institute.
- 6. The work of construction of second floor on the Department of ECE was found to be satisfactory by the inspection committee. The newly constructed second floor has been taken over by the Department.
- 7. The work of renovation of four staff quarters was found to be satisfactory by the inspection committee. Subsequently the renovated quarters were taken over by the Institute.
- 8. While inspecting the work of re-carpeting the internal roads in the campus, the joint inspection committee pointed out to CPWD deficiencies in the quality in some stretches of the road. A second inspection was carried out in second week of March, 2014. The committee was not happy with the quality of work in some stretches of the roads. The Department of Civil Engineering was requested to conduct tests on these stretches of the road and suggest remedial measures. The test report from the Department is yet to be submitted.
