National Institute of Technology Warangal Innovation and Entrepreneurship Foundation (NITWIEF) established by National Institute of Technology (NIT) Warangal under Section 8 of The Companies Act, 2013. NITWIEF aims at nurturing a startup ecosystem at NIT Warangal. The goal is to cultivate and enhance a culture of entrepreneurship and innovation by facilitating, enabling, and fostering entrepreneurial efforts. This includes providing support, funding, mentorship, and management for initiatives and ventures, ultimately driving the development and success of entrepreneurial endeavors.

REMUNERATION:	A consolidated pay of around Rs. 1,30,000/- per month based on the candidates' experience and profile will be offered. Remuneration and final offer may differ based on relevant experience and the performance of the candidate.

ROLE:

As the CEO of the newly formed Section-8 company, the individual will oversee and coordinate various operational roles, including project management, business development, finance, and administration. The job description is not exhaustive, and additional related duties may be required as needed. The CEO will be responsible for building and leading a team of professionals to achieve the objectives of NITWIEF.

RESPONSIBILITIES:

- a) Being the founding CEO, define and build the core nucleus of the organization, structure, functioning processes in line with the purpose and vision of the hub.
- b) Build relationships with all stakeholders (professors, researchers from other Institutes/universities and research organizations in India and abroad, start-up

companies, industries, etc.).

- c) Should be able to work with Board of Directors of the company and Center for Innovation and Incubation (CII) of NIT Warangal.
- d) Should be able to work with the staff to define mission, staff management, financial management, legal issues management, accountability, and effectiveness.
- e) Work effectively to generate and manage funds for the company to be self-sufficient.
- f) To assist in approving allocation of funds to various projects and monitor the progress of these projects and provide periodic reports to the Board.
- g) Other related works assigned time to time by the Board of Directors.
- h) To carry out financial appraisal of projects and to prepare/examine financial statements of the company and highlight achievements and failures and suggest course corrections
