But the Agenda with Notes and the draft resolutions could not be sent to Sri G.Venkateswara Rao, Associate Professor, Dept. of Mechanical Engineering, NIT, Warangal, as he submitted a letter on 3rd January, 2018 to the Chairperson I/c, BoG requesting for relieve from the responsibility, assigning personal medical & health reasons. Upon the above, the Chairperson I/c, BoG accepted the same. In this regard, it is proposed to place on record the services rendered and the contribution made by Sri G.Venkateswara Rao, Associate Professor, Dept. of Mechanical Engineering, NIT, Warangal, as one of the Internal Members of the BoG.

At the same time, it is equally important and worth mentioning here that Sri C.B.Rama Rao, Associate Professor, Dept. of ECE, NIT, Warangal, has been nominated as one of the Internal Members on the BoG of the Institute w.e.f. 02-02-2018 by the Chairperson I/c, BoG. Pursuant to the above, the Agenda with Notes and the draft resolutions were also sent to the above new Member on 02-02-2018.

While circulating the Agenda with Notes and the draft resolutions, the Members of the BoG were requested to send their consent with comments, if any, on or before 9<sup>th</sup> February, 2018, else it would be construed that the Members of the BoG confirmed the circulated resolutions and accordingly the minutes would be finalized. And in response to the above, on 09-02-2018 the following comments were received from Smt. Darshana M.Dabral, Joint Secretary & Financial Advisor, MHRD, Gol, New Delhi, one of the Members of the BoG, on Agenda Item No.42.2:

"There is no objection to the proposal. However, the possibility of sharing the additionality from the IRG may be explored fully. Also, arrears to faculty and non-faculty staff should be paid only after paying salary to them."

Except the above, no comments were received from the rest of the Members of the BoG on or before the given time i.e., 09-02-2018. Against this back drop, the Chairperson I/c, BoG, looked into the Agenda Items keeping in view the comments received from one of the Members of the BoG and accordingly finalized the following item-wise resolutions on the Agenda Items:

	RESOLUTION  Consequent to the approval of the Resolution of Finance Committee taken in its 32 <sup>nd</sup> meeting, the BoG passed a resolution to extend the benefit of revision of Pay to the Faculty and the Non-Teaching staff of NIT Warangal, w.e.f. 01-01-2016 in compliance with guidelines communicated by the MHRD Gol, New Delhi vide letters (1) F.No. 15-4/2017-TC, dated 27 <sup>th</sup> October 2017 and (2) F.No. 15-1/2017-TC (Vol.II), dated 29 <sup>th</sup> December 2017 respectively, following the Pay revision of Central Government employees on the recommendation of the 7 <sup>th</sup> Central Pay Commission.
	The Board also asked the Institute to explore the possibility of sharing the additionality from the IRG fully, if possible. At the same time, the Board directed that the pay revision related arrears due to faculty and non-teaching staff of the Institute should be paid only after paying the salary as per the 7 <sup>th</sup> CPC recommendation to the extant of guidelines communicated by the MHRD in this regard so far.

With the above, the minutes are finalized so as to proceed further in the matter to meet the

urgency.
