While the Committee approved the Project in principle, the Institute was advised to include the same in comprehensive proposal for HEFA loan. The Director and other representatives informed of the limitations in repayment of HEFA loan, in view of limited IRG. It was informed that while HEFA loan will be taken for construction of hostels and academic buildings, purchase of equipment may be permitted with the grants under OH 35. The Committee advised the Institute to explore the possibility of awarding construction of hostel buildings on BOT basis in future. The Institute was also advised to prepare a prospective plan for the next five years and submit to the Committee.
