The Board noted that Shri K.V. Sridhar has submitted representation dated 21-10-2018 expressing regret for the unintentional mistake and sought pardon for the same. Taking note of the fact that the alleged plagiarism is from his own works and that of his students and that he has not been allowed to register for Ph.D or to guide any student during the last four years, the Board resolved to take a lenient view on the misconduct committed by Shri Sridhar. Although the Inquiry Officer suggested penalties to be imposed on the charged Faculty member, the Board noted that the Inquiry Officer has acted ultravires and decided to ignore the recommendation. Further the Board has come to the conclusion that imposition of penalty of Censure on Shri Sridhar would meet the ends of justice and has resolved to impose the penalty of Censure accordingly.

The Board has also decided that all proposals for appointment as Emeritus Professor should first be considered by a Committee consisting of Director, Deans (FA, RC & Academic), Senior BoG Member from the Institute, Registrar and Head of the Department concerned and thereafter by the Senate before putting up the same to the BoG. Similarly all proposals for appointment of Visiting Faculty and Adjunct Faculty be also put up to the Departmental Committee and then to Senate, before Director accords approval. Appointment of Emeritus Professor, Visiting Professor and Adjunct Faculty shall be subject to the following conditions:

a) Such appointments shall be against sanctioned faculty strength; and

b) The total number of Emeritus Professor, Visiting Professor and Adjunct Faculty shall not exceed 10% of the sanctioned strength of the faculty of the Institute.
