As no comments have been received from the Members on the draft Minutes, the Committee resolved to confirm the Minutes of the 49 <sup>th</sup> Meeting of the Board of Governors.

50.3	To consider and approve Proceedings of Selection Committees for recruitment of Assistant Professor Grade-II in the pay level of 10 & 11 (AGP-6000 and AGP-7000 in the 6th CPC) in various Departments in NIT Warangal held during 13th to 24th October 2019.  The Board was informed that the following procedure was adopted in selection of Asst. Professors Grade-II in NIT, Warangal against the advertisement Nos. 02/2018 and 01/2019:  **Phase-1:** Scrutiny of applications was done as per the eligibility criteria specified in the advertisement and arranging the eligible candidates in the order of the merit. Candidates were called for the selection process based on the number of vacancies available in each department in the ratio of 1:10.  **Phase-2:** Shortlisted candidates were called for Seminar/Presentation in the respective Departments. Screening Committee comprising an external expert and three members from the Institute (Head of the Department, senior most Faculty of the Department and a Professor from outside the Department and a Professor from outside the Department) evaluated the presentations as per the guidelines framed. It was an Open Seminar. Candidates were shortlisted in the ratio of 1:5 taking reservations into consideration.  **Phase-3:** Shortlisted candidates in phase-2 were called for the Interview as per the given schedule. It was ensured that the constitution of the Selection Committee and process of selection were as per the statutes of NITs and guidelines issued by MHRD from time to time.  The Board was informed that 73 candidates were	The Board appreciated the transparent and fair selection procedure adopted by the Institute and resolved to approve the proceedings of the Selection Committees for recruitment of candidates to the post of Asst. Professor GrII and promotion of 10 Professors to the HAG grade. The Board has also authorized the Institute to declare the results of the recruitment and issue orders of appointment to the selected candidates, immediately, without waiting for approval of the minutes of the meeting of the Board.

The Board was informed that as Shri Chandrasekhar was holding the post equivalent to Asst. Registrar from the date of his appointment i.e., 28.08.2000 and has been re-designated as Asst. Registrar, the Selection Committee in its meeting held on 30.04.2019 interviewed him and found him suitable for promotion to the grade of Dy. Registrar. As per the Recruitment Rules 2019 Asst. Registrar with a regular service of at least 10 years, with at least 5 years with GP of Rs.6600/and working performance record is eligible for promotion to the grade of Dy. Registrar. Since, Shri Chandrasekhar is notionally eligible to the GP of Rs.6600/- w.e.f. 1.1.2014, he can be considered for promotion to the grade of Dy. Registrar w.e.f. 1.1.2019. As the Selection Committee meeting was held on 30.04.2019, it was requested to consider his promotion from 30.04.2019 on notional basis and monetary benefit from the date of approval of Board.
