Agenda No. BoG - 61(2023)-06:

Status of recruitment of Non-Faculty and approval of External Subject Experts and other members of the Selection Committee

The Board noted the status of recruitment of 29 non-faculty members – Group A, B & C (vide Advt. No. 01/2023 and 02/2023) and approved the list of nominee of the Board for the selection of the Group-A posts, such as Registrar, Dy. Registrar and other Officer posts (Annexure-2). The Board has authorized the Director to invite the nominees as per the provisions of the NIT Statutes.

The Board has approved to take the assistance of NTA for conducting the written tests for Group B and C posts.

Agenda No. BoG - 61(2023)-07:

To consider the proposal for appraising Telangana State Govt. or Ministry of Defence for obtaining additional land of 300 Acres for meeting future growth plan for Campus Expansion for Academic and R&D Activities.

The BOG suggested the institute to initiate measures to get additional land (about 300 acres) in and around Warangal from the Government of Telangana free of cost. Further, a letter from MoE to the Telangana Govt. may be sent for providing additional land near to Warangal. Also, Ministry of Defence may be appraised for possible allocation of additional land.
