


Minutes of the 77th senate meeting

The i/c Registrar welcomed the i/c Director, new external senate members and new Associate Deans (Examinations & PG). The i/c Director placed on record the services rendered by Prof. T. Srinivasa Rao, Ex-Director, Prof. G.V.P. Chandra Mouli , Dept of Chemistry who superannuated on 30th June 2016, Prof. Chidambaram and Prof. Seshu Bai , External members of senate who completed their term.

THE FOLLOWING DECISIONS WERE TAKEN:

Sl. No.	Item No.	Decision taken
1.	To confirm the minutes of 75 th and 76 th Senate meetings held on 25.05.2016 and 16.06.2016 respectively.	Confirmed
2	To approve the second semester results of II nd M. Tech and III Year M.Sc. (Tech)	Approved. It is generally felt that in the case of grades for the dissertation works which are having varied nature in the problems handled and the evaluation process, it is not possible to fit in the normal curve. Also, the number of students is very small in these classes.
3.	To form general guidelines for PG curriculum updating	After thorough deliberations, the following general guidelines are formulated for M. Tech courses.
		To bring uniformity among requirements for the award of M.Tech. Degree, the senate decided the structure of the programme comprising of 6 core subjects and 6 elective subjects with 12 courses in total during I and II semesters in all with a flexibility to decide the proportion of core to elective subjects in each semester with a maximum of 6 subjects in each semester.
		Core courses carry a weightage of 4 credits and elective courses with 3 credits. Maximum of two laboratories in each semester is accepted along with 6 theory subjects.
		Seminar with a weightage of 1 credit is included in I and II semesters uniformly across all specializations.
		Industrial training at the end of II nd semester for a maximum period of 8 weeks is allowed on optional basis.
		At the end of III rd semester a comprehensive viva voce with a weightage of 2 credits is decided and the dissertation Part A will have

	a weightage of 6 credits. The final dissertation Part B at the end of IV semester has a weightage of 12 credits. It is recommended that common core courses between any two M.Tech. Programs of the same department shall not be more than 2 for the two semesters together. However, based on the need, electives among the programs can be common.
Evaluation process	The comprehensive viva voce will be conducted by an external examiner with not more than 10 students per day per program.
	The chairman senate will constitute a committee to prepare rubrics/guidelines for the uniform evaluation of M.Tech. Dissertation (Part-A and -B) to be implemented for the batch admitted during 2016-17. However, the evaluation process for dissertation works of the current students will be as follows:
	Dissertation Part-A will be evaluated by internal committee. The supervisor and the committee shall provide the evaluation of the student dissertation Part A to the faculty advisor. If the advisor does not receive the evaluation by the deadline from any of the above, he/she will be taking the evaluation available for finalization of the grade and will be placed before the appropriate authority for necessary action.
	Dissertation Part-B will be evaluated by the committee with external examiner. The supervisor and the committee (including the external member) will be giving the evaluation to the faculty advisor. If the advisor does not receive the evaluation by the deadline from any of the above, he/she will be taking the evaluation available for finalization of the grade and will be placed before the appropriate authority for necessary action.
About online courses	Students are encouraged to take online courses. However, the grade sheet will contain grades of the subjects which the student has taken on the campus.
	The grades for the online courses will not be reflected in the grade sheets issued by the

	Courses from other departments	The students are encouraged to take elective courses across the departments if the courses are authorized by the department to be relevant to the program. However, a student is permitted to take such interdepartmental elective only one per semester.
	M. Sc courses	The Maths, Physics and Chemistry departments a re to prepare and present the curricula for their courses on the above lines in the next senate.
