The Senate noted the nominations.

- a) Ms. Sri Vidhya Komarina (Roll No. 21ECSJ093) a Full-time Research Scholar (Self-financing) of Electronics and Communication Engineering has made a request for one more semester break based on her health condition. The Doctoral Scrutiny Committee (DSC) of the Scholar has recommended the request.

This is to bring to the notice of the Senate that the Scholar has been already given one-year break as a special case in 129th Senate meeting. The Senate may consider the request and recommendation of DSC.

The Senate approved the request for one more semester break from July – December 2024.

- b) Mr. P. Chandra Sekhar (Roll No. 716169) a Part-time Research Scholar of Chemical Engineering working under the supervision of Prof. Anand Kishore Kola has made a request to consider him for re-admission into the PhD program afresh. The Scholar has completed 8 years in July 2024. The DSC and DAC (PG&R) have both recommended that the request may be considered favourably.

The Senate discussed in detail and referred the proposal back to the DSC. The DSC is requested to comment on the quantum of the work carried out, status of papers published and the amount of time required to submit the thesis. Based on the inputs, the Chairman, Senate is authorized to take a decision.

- c) Ms. Korimi Prathyusha (Roll No. 21HSRER03) a Full-time Research Scholar of Humanities and Social Sciences has made a request for conversion of her registration from Full-time to Part-time, to take up the employment offer as Lecturer in Tribal Welfare Degree College, Telangana.

The scholar has completed five semesters. As per the regulations the scholar should have completed three years / six semesters to be eligible for such conversion.

As the Scholar has completed 60% of the research work, the DSC recommends that the request may be considered.

The Senate did not approve the request for Part-time conversion, as she has not completed the requisite period in her PhD program as per the regulations.

- d) Mrs. K. Sujatha (22PHR2Po3) a part-time Research Scholar of Physics has made a request to allow her to appear for Comprehensive Viva Voce exam in the 4th semester on medical grounds. The DSC has recommended that the request may be considered favourably.

The Senate approved the recommendation of the DSC.

e) Promotion Issues:

- (1) Students having one/two backlogs in (n-2) year are requesting that they may be promoted. *As per the promotion rules, students shall not have a backlog in (n-2) year to be able to promote to the nth year.*

- (2) Students who were placed under Academic Probation are requesting that they may be promoted to 7th Semester.

For the sake of such students who could not be promoted, Senate has approved Academic Probation in the 128-A Senate Meeting.
