All the **PwD** candidates (*should bring original PwD UDID card/PwD certificate) have to report @ 8.45AM on the respective dates during 17th August, 2026 at **Dr. B.R. Ambedkar Learning Centre (ALC)** for physical verification of certificate and examination by Medical Board through the Sr. Medical officer, **Institute Health Centre (IHC), NIT, Warangal**

NOTE: Other fee per year from second year onwards in Rs. 12,500/-. Convocation fee of Rs. 2,500/- will be collected in the final year and Rs. 200/- towards postal charges will be collected in the final year.

III. HOSTEL AND MESS FEES TO BE UPLOADED IN NITWAS ERP PORTAL

All admitted candidates are required to stay in the Institute hostels. Each PG student has to pay **Rs. 31,000/-** towards hostel accommodation in the odd semester of the academic year 2026-27. In addition to this, the mess advance of **Rs. 15,000/-** is to be deposited. Details are available at <https://admissions.nitw.ac.in/impinstructions/>

Refund policy:

The candidates who fail to physically report to the Institute will not get any refund. If any candidate wants to cancel his/her allotted seat after physical reporting to the Institute, he/she can send a request for cancellation to the PIC (Admissions) through the respective Head of the Department. In that case, the candidate should provide the Bank account details (Name of the account holder, Account Number, Name of the bank branch, IFSC code) along with the proof (either a copy of cancelled cheque or front page of the bank passbook). The account must be in the name of the candidate. Such candidates are eligible to get the refund of **Rs. 3,000/- (three thousand) only**. The refund amount will be transferred to the candidate's bank account only after receiving the amount from NIMCET. The tentative timeline of receiving the amount from NIMCET is February/March, 2027.

IV. STEPS TO BE FOLLOWED BY CANDIDATES FOR DOCUMENT UPLOAD IN NITWAS ERP AND PHYSICAL REPORTING FOR M.C.A.

1. Login to ERP/NITWAS Portal

- Upload all **required documents** as per the list provided in the admission instructions.
- Once the **online verification is completed**, download and **take a printout of your PROFILE** from the **NITWAS ERP** portal.
- This **PROFILE** must be **submitted during physical reporting** at NIT Warangal.

2. Physical Reporting at NIT Warangal

- All **selected candidates must report in person** as per the schedule notified.
- Bring all **original certificates** for final verification.
- Submit original documents as per the institute's instructions after successful verification.

IMPORTANT NOTES

- **Candidates will not be allowed for physical reporting without completing verification through the NITWAS ERP portal.**
- If a candidate is **unable to download the PROFILE**, it indicates that:
 - Their **M. Tech / M.Sc / M.Sc.(Tech)/MA/M.C.A admission is either rejected**, or
 - A **query has been raised** regarding their documents.
- If the candidate **fails to resolve the query** within the stipulated time, they will be **deemed ineligible for M. Tech / M.Sc / M.Sc.(Tech)/MA/M.C.A admission**.

It is strongly advised that all candidates **check their NITWAS ERP portal regularly** to ensure verification is complete and to avoid last-minute issues.

Important Note:

Candidates who have passed their qualifying examination in the academic year 2025–26 and are awaiting the issuance of the required documents may submit the prescribed self-declaration(s), as provided in the following pages, at the time of admission. All qualifying examinations must have been successfully completed on or before 15 August 2026. The pending documents shall be submitted to the Institute on or before 30 September 2026. Failure to submit the required documents within the stipulated time, or failure to satisfy the prescribed eligibility requirements, shall result in the cancellation of the provisional admission and the allotted seat, without any further notice.
