To confirm the minutes of 50 th meeting of the Senate held on 06.01.2012.	<p style="text-align: center;">Approved</p> <p>Members of Students council have represented for reconsideration of earlier decision regarding allowing a candidate with "F" grade after make-up to the subsequent End Semester examinations only without registering to study the entire course. Senate discussed the issue and resolved that there shall be no deviations in the decisions taken at the 50th Senate meeting.</p>
2.	To approve the examination results of First semester of UG and PG programmes for the academic year 2011-12.	<p>The Senate has considered the grades recommended by the respective Departmental Academic Committees and observed certain deviations in the award of grades in certain courses. It is resolved to review the grades in the subject of POC laboratory of III B.Tech(Chemical Engg.) and all courses in M.Tech.(IM) and M.Tech(MT) and authorized Chairman, Senate to approve the modification. All the remaining grades presented are approved.</p> <p>Further, it was clarified that uniform evaluation and grading has to be followed for all courses including laboratory courses with the same course number. However, the DAC-UG or DAC-PG & R is authorized to adopt multiplicative normalization procedure , if need arises, in case of Laboratory courses only.2</p>
3.	Proposal from the Department of Physics to consider introduction of new courses: (i) B.Tech. (Engineering Physics) (ii) M.Tech. (Opto Electronics). Institute has appointed a committee to look into the feasibility of starting of the two programmes. The committee has given its recommendations.	<p>The Senate has considered the report submitted by the committee appointed to look into the feasibility of starting of new programmes. After deliberations, Senate decided to defer the issue of starting of new programmes for sometime, till consolidation of existing programmes is completed. It is unanimously decided not to start any new programmes in the ensuing academic year, 2012-2013.</p>
