Students of I year – II semester B.Tech. (All branches) programme in the year 2015-16, who are expecting to satisfy the eligibility criteria (given below) and who are desirous of applying for change of branch from their present branch of study, are required to submit an application on or before 03-05-2016 to Assistant Registrar (Academic), Academic Section and collect receipt. The prescribed application form is available in the Academic Section as well as in the website.

Eligibility for applying for change of Branch:

(as extracted from the “Rules and Regulations for B.Tech. Programs” book and read this book for more details)

1. Only those students will be eligible for consideration for a change of branch after the I year II semester, who have

a) have completed all the credits in I year – I semester and in I year – II semester.

b) obtained a CGPA of not less than 8.0 at the end of the I year II semester in single attempt only.

2. Students who are repeating I year are not eligible.

Students may enlist up to seven choices of branch in order of preference to which they wish to change over. It will be permissible to alter the choices after the application has been submitted.

Change of branch shall be made strictly on the basis of inter se merit of the applicants. For this purpose, the CGPA obtained at the end of the I year II semester shall be considered. Ties will be resolved by All India Rank based on which the admission was given.

All changes of branch will be effective from the II year I semester of the applicants concerned. No change of branch shall be permitted thereafter.

All changes of branch will be final and binding on the applicants. No student will be permitted under any circumstances to refuse the change of branch offered.
